

TOURNAMENT DETAILS

The tournament will be played over 45 holes on Friday and Saturday. Play is governed by the USGA Rules of Golf and, where applicable, by the enclosed Canoe Brook Local Rules. Each team will play three 9-hole matches on Friday and two 9-hole matches on Saturday. In the event of foul weather, play may be suspended by the Professional staff only. Players may not choose when to cease play. There are two formats to be concerned with in scoring. The flight winners and runners-up will be scored as follows:

FLIGHT FORMAT: There will be 6 teams per flight. Flights will be determined by combined team handicaps. Every team will play a 9-hole match against each other team in its flight. The format will be Four-Ball Match Play (Better Ball of Partners) with handicap and scoring as listed below:

All Play will be at 90% of course handicap. 18-Hole handicaps will be halved for the 9-hole matches. The lowest handicap player in each match will play at scratch, all other handicaps in the group will be at the full difference in handicap with 1/2 strokes counting as they fall on the card.

- If a flight has an odd number of teams, they will play 1 of their matches where it falls in sequence, Match Play vs. Par.
- If one or both members of a team are a "no show", the opponents will play the flight match as Match Play vs. Par. For the "no show" team, if one member shows, that member will play the flight match as Match Play vs. Par, and if both members are "no show", the team will receive "0" points. Two players vs. one player will not be permitted.
- PLEASE NOTE: IF A TEAM PLAYS A MATCH AGAINST PAR, THAT TEAM WILL RECEIVE THE POINTS EARNED AGAINST PAR OR THE AVERAGE NUMBER OF POINTS THAT TEAMS IN THAT FLIGHT EARNED AGAINST THE"NO SHOW" TEAM WHEN THEY PLAYED ANY OF THEIR MATCHES. TEAMS THAT PLAY FEWER THAN 5 HOLES VERSUS PAR OR A TEAM THAT CREATED A VERSUS PAR SITUATION WILL NOT QUALIFY FOR THIS RULE AND MUST TAKE THE POINTS EARNED VERSUS PAR.

MATCH SCORING SYSTEM: 9 points will be awarded for each 9-hole match as follows:

- 1 point for winning each hole
- 1/2 point for each hole halved
- All matches are to be played the full 9-holes. The most points scored in the flight wins that flight. If a tie in a flight occurs, the winner will be determined by the performance against the other tied teams. In the event a tie still occurs a putt-off will decide the winner.

Overall Format: The Overall Champion will be determined by a shootout of the Flight Winners immediately following the 5th match. This shootout will take place on the 9th hole on the NORTH COURSE at approximately 3:00 PM. Players with a NORTH COURSE Handicap of 0-9 will play from 175 yards, Players with a NORTH COURSE Handicap of 10-19 will play from 160 yards, and Players with a NORTH COURSE Handicap of 20+ will play from 145 yards. Teams will play alternate shot format with no handicap.

PRIZE POOL: The prize pool will be distributed to the Overall Champions, Flight Champions, and Flight Runners-up; Closest to the pins and highest point total per day in each flight. Each team in the flight of the Overall Champions will receive a distribution from the prize pool as well. In the event of a tie for flight runners-up and highest point totals per day, prize money will be split amongst both teams.

Speed Of Play: Rangers will be monitoring pace of play. All groups will be expected to keep pace with the group in front of them. Repeated infractions will result in the Golf Committee taking appropriate action against the players involved

Special Events: Closest to the Hole on All Par 3's. Beat the Pro: #5 on the NORTH COURSE on Friday during Rounds 1 & 2 and Saturday during Rounds 4 & 5.



LOCAL RULES

Play is governed by the USGA Rules of Golf and where applicable, by the following local rules. Unless otherwise provided, penalty for breach of a Local Rule is two (2) strokes in Stroke Play and loss of hole in Match Play.

- 1) Suspension & Discontinuance of Play: **Suspension of Play** Lightning alarm sounds. **Discontinue Play Immediately (Dangerous Situation)** Slow multiple horn sounds. **Resume Play** One long horn sound.
- 2) Artificially Surfaced Roads: Artificially surfaced roads and paths are obstructions. White lined areas tying into roads or paths have the same status as the roads or paths, and thus they are obstructions and not ground under repair. Cart damage adjacent to paths is considered part of the obstruction. Take relief without penalty under Rule 16.
- 3) Dropping Zones: If a ball is in or it is known or virtually certain that a ball that has not been found is in the penalty area on #5 North Course or #10 South Course, the player may:
 - a. Proceed under Rule 17; or
 - b. As an additional option, drop a ball, under penalty of one stroke in the Dropping Zone.
- 4) Out of Bounds: White stakes, boundary and cyclone fences define out of bounds. On the North Course the fence defining the swimming pool also defines out of bounds.
- 5) Sod Seams: Through the green, seams of cut turf (not the turf itself) are deemed to be ground under repair. However, interference by a seam with the player's stance is deemed not to be, of itself, interference under Rule 16. If a ball lies in or touched the seam or the seam interferes with the area of the intended swing, relief is available under Rule 16. All seams within the cut turf area are considered the same seam.
- 6) Aeration Holes: Through the green, a ball that comes to rest in or on an aeration hole may be lifted without penalty, cleaned and dropped as near as possible to the spot where it lay but not nearer the hole. The ball when dropped must first strike a part of the course through the green. On the putting green, a ball that comes to rest in or on an aeration hole may be placed at the nearest spot not nearer the hole that avoids the situation.
- 7) Preferred Lies/Winter Rules: If Preferred Lies or Winter Rules are posted for the day's play, a ball on your own fairway may be lifted, cleaned, and placed within one (1) club length of the ball's original position. The ball may be placed and must not be closer to the hole than the original position where it lay that is not on a putting green or in a penalty area.
- 8) Greenside Fans (North #14 & #16, South #7): The fans at greenside are deemed to be temporary immovable obstructions. Relief is allowed for interference with lie of the ball, stance, or area of intended swing. Relief is also allowed if the fan intervenes on your line of play to the hole. You must find the nearest point of relief, keeping the nearest edge of the fan between you and the hole. Once that nearest point is established, you must measure one (1) club length no nearer the hole and then drop the ball outside that one (1) club length, but no more than two (2) club lengths from the nearest point of relief.
- 9) Practice in Stroke Play: Competitors may play the golf course the same day of a Stroke Play event, after the competition has closed for the day, without disqualification.
- 10) DISTANCE-MEASURING DEVICES: A player may obtain distance information by using a device that measures distance only. If, during a stipulated round, a player uses a distance measuring device that is designed to gauge or measure other conditions that might affect his play (e.g. gradient, wind speed, temperature, etc.), the player is in breach of Rule 4.3a, for which the penalty is disqualification, regardless of whether any such additional function is actually used.

LOCAL RULES

NORTH COURSE:

Holes #4 & #6 - A ball that lands in the 5th hole water hazard when you are playing either Hole #4 or #6, may be treated as if the hazard was a lateral water hazard.

Hole #5 - Refer to Local Rule #3.

Holes #9 & #18 - If a ball lies within the flower and shrubbery area left of the 18th green or behind the 9th green, the player without penalty, may drop the ball within one (1) club length of their nearest point of relief, no closer to the hole.

Hole #10 - The cart path along the left side of the hole, between the pine trees and boundary fence is deemed to be an obstruction.

Hole #12 - The edge of the mulch bed around the patio defines the edge of the obstruction. The bushes around the patio are considered an obstruction. Under Rule 16, players are entitled to relief and one (1) club length no nearer the hole.

Hole #13 - The Practice Range is treated as Out of Bounds beyond the white stakes. The nets, telephone poles, and guide wires are considered obstructions even if they are out of bounds and the player's ball lies in bounds. Under Rule 16, players are entitled to relief and one (1) club length no nearer the hole.

South Course:

Holes #2 & #5 - The flower bed behind the 2nd green, as defined by the edge of the mulch, is deemed to be an obstruction. If a ball comes to rest in or on the obstruction, a player may take relief without penalty. (Rule 16) Hole #10 - Refer to Local Rule #3.

Holes #11, 13, 14 & 15 - CBCC maintenance area is considered an obstruction and the margin is defined by black stakes. The player may find their nearest point of relief under Rule 16. As an additional option, the player may find their nearest point of relief from the point where the ball crossed the margin of the black stakes and drop within one (1) club length of that point no closer to the hole. No penalty.

Hole #18 - The barns located off the 18th fairway are considered immovable obstructions. Take relief without penalty under Rule 16.

Please check the Local Golf Rules posted for the day as they are subject to change.


